## 2. Essay

Please write an autobiographical essay (not longer than 5 pages), that will include most important historical, emotional and spiritual events in your life. Please include the following information.

- Your motivation to start Core Energetics training;
- Your strong and weak aspects in your private and professional life;
- Your personal and professional goals;
- Most meaningful life experiences;
- Your readiness to undertake the four-year commitment;
- Your expectations regarding how this training might impact your personal and professional life;
  - Do you have any health problems, injuries or restrictions that might limit your participation in physical and energetic exercises during the training;
  - Were you a victim of physical or sexual abuse in your life, were there any other traumas that we should know about;
    - Were you ever arrested or had any sort of legal or ethical case against you;
    - Have you ever had any sort of addiction (drug, alcohol, sexual, gambling, etc.) If so please specify;
    - Have you ever had suicidal attempts;
    - Do you currently take medication, if so, what kind and what conditions are being treated;
    - Have you been diagnosed with any kind of psychiatric disorder, if so, what is it;
    - Have you been hospitalized because of mental or emotional problems.

## 3. Recommendation Letters

Please deliver two recommendation letters written by people who know you and can recommend you to a professional program such as ours. These letters should be written by people who know and support your motivation and have arguments to justify your participation in this program. The letter should include addresses and phone numbers of the person who wrote it.

We suggest that you'd ask for the letters from people from your professional environment. Someone who knows you personally (manager, supervisor, colleague) or someone from your private life (it could be also your therapist). We are asking that the person who agrees to write this letter would include information about

1. Introduce themselves, describe the connection between the two of you.
2. Describe how he/she sees you in context of this training and why they think it is a good choice for you. Also describing your qualities as a student, worker, friend, etc., depending on what area of your life they are coming from
3. Describe how do they see your involvement in your own personal growth and in life, and in serving others.

## 4. Registration fee

After receiving the complete documentation, the process of examining the application begins. The next step is an interview (personal or online) with the Directors of Training Alicja Konopko and / or Elizabeth Carl. We will contact you to arrange a convenient date.

### **Organizational information:**

The basic fee for the year of training is 11600 PLN. The payment is spread over installments - initial payment 3000 PLN after a positive decision about acceptance for training, and 4x 2150 PLN regulated before each exit.

The cost of the accommodation during the modules and individual therapeutic sessions (as well as any costs related to their organization) are on the side of the Training Participant. During the year, 4 basic conventions are planned, from Wednesday to Sunday, and additional days during the 3rd and 4th years.
